### DEPOSIT AND PAYMENT SCHEDULE

\$600	Deposit	Due ASAP or no later than July 1, 2012
\$600	Installment 2	Due on or before July 1 (for single supplement, please add \$325 to this payment)
\$695	Final payment	Due on or before Aug. 15

Payment in full is required when bookings are made after Aug. 15, if space is available. Group size is capped at 24; and spaces will be filled in the order in which reservations and deposits are received. If we receive more reservations, we will keep a waiting list in the event of cancellations.

### CANCELLATIONS AND REFUNDS

*Notification of cancellation must be made in writing, with the cancellation date being the postal service postmark date. At the time we receive your notification, the following charges apply: (charges are per person)*

120-74 days before departure:	\$150 plus Green Mountain Fibers costs and charges by suppliers
75 days before departure	\$200 plus Green Mountain Fibers costs and charges by suppliers

After this point, you will be refunded whatever amount we can recoup from all of the suppliers who have been paid. Trip cancellation insurance is available and is recommended. Refunds for services that are voluntarily not used will not be made.

### TOUR RATES

**The right is reserved to change any route or arrangements should conditions necessitate, to offer substitutes of equal value, or to cancel the operation of any scheduled excursion.** Individual transfers for those arriving or departing independently are not included in the land cost unless otherwise stated. All rates quoted are based on current tariffs and on the **current value of foreign currencies in relation to the United States dollar, and are subject to adjustment in the event of changes before the departing dates.**

### RESPONSIBILITY
